### **Privacy Policy**

Effective Date: January 1, 2026

Welcome to Tricked Out Vault (“we,” “us,” or “our”). Your privacy is critically important to us. This Privacy Policy explains how we collect, use, and protect your information when you use our storage platform designed for magicians to upload, organize, and manage their tricks, media, and related resources (“Services”).

#### ***1. Information We Collect***

- Account Info: Name, email, password, optional profile info
- Content: Tricks, notes, videos, files you upload
- Usage Data: Device, IP, features used, log data
- Cookies: Used to improve performance and personalization

#### ***2. How We Use Your Information***

To provide and improve services, secure your account, personalize content, communicate with you, and analyze trends.

#### ***3. Sharing***

We do not sell your data. We share only with service providers, for legal compliance, or in case of business transfers.

#### ***4. Your Rights***

- Access, correct, or delete data
- Restrict or object to processing
- Data portability

#### ***5. Security & Retention***

We use industry-standard protections and retain data only as long as needed.

#### ***6. International Users***

Your data is stored in the U.S. and may be transferred and processed accordingly.

# **Terms of Service**

Effective Date: January 1, 2026

## **1. Eligibility**

You must be 16+ to use the platform. If you are under 18, you must have parental consent.

## **2. Account Responsibility**

You agree to provide accurate info and safeguard your account. Don't use our Services for unlawful purposes.

## **3. Content Ownership**

You retain ownership of everything you upload.  
You grant us a limited license to host, display, and improve our services.

## **4. Acceptable Use**

No harmful, illegal, or infringing content. No scraping, abusing, or reverse engineering the system.

## **5. API Usage (if applicable)**

Must respect user permissions, privacy, and system limits. We may revoke access at any time.

## **6. GDPR Compliance**

We comply with GDPR for all EU/EEA users. Rights include:

- Access, rectification, erasure
- Restriction, objection
- Portability

## **7. Children's Privacy**

Not for users under 16. We do not knowingly collect data from minors.

## **8. Third-Party Services**

You may interact with integrated services, governed by their terms.

## **9. Termination**

We may suspend accounts violating these terms. You may delete your account anytime.

## **10. Disclaimer & Liability**

Services provided “as-is.” No liability for lost files or indirect damages. We strongly recommend maintaining independent backups of your data.

## **11. Account Inactivity**

If you do not log in or access your account for a continuous period of 12 months, Tricked Out Vault may classify your account as inactive. We will notify you via email before taking any action. If no response or login occurs within 30 days of notice, we may close the account and delete stored data.

## **12. Service Modifications and Pricing**

We reserve the right to update, modify, or discontinue any part of our services, features, or pricing. Any pricing changes will be communicated in advance, and users will have the option to cancel subscriptions before renewal at the updated rate.

## **13. Subscription Renewals and Trials**

Unless stated otherwise, subscriptions auto-renew at the end of each billing period. Promotional trials automatically convert to paid subscriptions unless canceled before the trial ends. Renewal dates and pricing are always visible in your account dashboard.

## **14. Billing, Subscription Management, and Chargebacks**

### **Subscription Billing:**

All subscription fees are billed in advance on a recurring basis in accordance with the plan selected at the time of purchase. Subscription charges are non-refundable, except where required by applicable law.

### **Plan Changes and Cancellations:**

You may upgrade, downgrade, or cancel your subscription at any time through your account settings. Plan upgrades take effect immediately, while downgrades and cancellations take effect at the end of the current billing period. No partial refunds or credits are provided for unused time or unused storage.

### **No Automatic Plan Upgrades:**

Tricked Out Vault does not automatically upgrade user accounts when storage limits are reached. Any plan upgrade must be initiated explicitly by the user.

***Chargebacks and Payment Disputes:***

If we receive a chargeback, payment reversal, or dispute from your payment provider, we reserve the right to suspend or terminate access to your account until the issue is resolved. During this period, access to stored content may be limited. Repeated or fraudulent chargebacks may result in permanent account termination.

***15. Storage Limits and Enforcement******Storage Limits:***

Each subscription tier includes a defined storage allowance. Your total storage usage includes all files, videos, documents, and related data stored within your Tricked Out Vault.

***Enforcement of Storage Limits:***

When your account reaches or exceeds the storage limit associated with your current subscription tier, you will be unable to upload additional content until you either (a) upgrade to a higher storage tier or (b) delete existing content to reduce usage below the applicable limit. Tricked Out Vault does not permit uploads beyond a plan's allocated storage capacity.

***Notifications:***

We may provide notifications or warnings as you approach your storage limit. These notifications are provided as a courtesy and are not guaranteed. You remain responsible for monitoring and managing your storage usage.

***Feature Limitations at Capacity:***

While at or above your storage limit, certain features may be limited, including but not limited to uploading new content or modifying existing files. Access to existing stored content will generally remain available, subject to system availability and account status.

***System Protection and Abuse Prevention:***

To protect platform performance and reliability, Tricked Out Vault reserves the right to impose reasonable technical measures, including throttling, temporary restrictions, or suspension, if storage usage, file activity, or account behavior materially impacts system stability or violates these Terms.

***16. Lapsed vs. Canceled Account Policy***

Account Deletion Requests: If you explicitly request that your account be deleted, the deletion process begins immediately.

During the 30-day period, you may still reactivate your account.

After 30 days, your account and files will be permanently deleted and cannot be recovered.

***17. Legacy Contact Policy***

Users may designate a single "Legacy Contact" through their account settings. This person will be authorized to take control of your Tricked Out Vault account in the event of your passing.

Verification Process: The Legacy Contact must provide official documentation and identity verification.

*Data Transfer Procedure:* Upon approval, Tricked Out Vault will initiate a one-time export of the Vault to a physical hard drive and mail it to the verified contact.

*Limitations:* The Legacy Contact cannot resell or alter content until physical possession is complete.

*Revocation:* Users may change or revoke their Legacy Contact at any time.

## **18. Export Control and Legal Use**

Users agree not to upload, transmit, or store content that is subject to U.S. export control laws or international regulation.

## **19. Modifications to Terms**

We may update these Terms periodically. Users will be notified of significant changes. Continued use of the platform constitutes agreement to revised terms.

## **20. Governing Law and Dispute Resolution**

These Terms are governed by and construed in accordance with the laws of the State of Arkansas, without regard to its conflict of laws principles. Any dispute, claim, or controversy arising out of or relating to these Terms or the use of the platform shall be resolved through binding arbitration or, where arbitration is not required by applicable law, in the state or federal courts located in the State of Arkansas, and the parties consent to personal jurisdiction therein.

## **21. Platform Content**

### **User Content Representations:**

By creating an account and uploading any files, videos, documents, or other materials to the platform, you represent and warrant that you have lawfully purchased such content or otherwise possess the legal rights, licenses, or permissions necessary to store, access, and interact with the content for your personal use. You further acknowledge and agree that the platform is intended solely for private, individual use and may not be used to share, distribute, sell, resell, publicly display, perform, or otherwise make content available to third parties.

### **Platform Role and Disclaimer:**

The platform functions solely as a passive storage service provided at the direction of users and does not monitor, review, curate, license, distribute, transmit, or otherwise control any content stored on the platform. The platform does not enable or permit the sale, resale, sharing, public display, performance, or redistribution of stored content.

All content stored on the platform is uploaded at the sole discretion of the user. Any disputes regarding ownership, licensing, permissions, contractual obligations, or permitted use of such content are solely between the user and the applicable third party. Tricked Out Vault expressly disclaims any responsibility or liability arising from the content stored by users or the use of such content.
